According to Christianity and in the authority, the "seven deadly sin" is discussed. Violates such as perfection, lust, jealousy, arrogance, laziness are explained to the destruction of men that occur in human morals and behavior [2].

In general, religious teachings are interpreted as the primary threats of humility, animality, and violence against the essence of man, the "Satan's incorruptible." A person who aspires to God must be free of these qualities.

According to Islamic philosophy, the consequences that cause evil, evil ideas are "the ball of the nafs" and the desire. It is acknowledged that there are 7 different nafs in the teachings of the doctrine [3]. These are: 1. An-nasful-ammora, 2. An-nasful-lavvoma, 3. An-nasful-mulhama, 4. An-nasful-mutmayinna, 5. An-nasful-ridya, 6. An-nasful-mardiyya, 7. An-nasful-komila. It is taught that it is specific to the first and the other is not to perfection. For example, an-nasful-ammora - a sharp soul, the nafs (lust) that encourages a person to a miserable way. He embodies the characteristics of a person's physical nature, animal emotion, and various vices. According to the teachings of Sufism, ignorance, greed, arrogance, rage, jealousy, gossip, gossip, gossip, and others are signs of these lusts.

The second is the An-Boshsul-Lawsu - the criticism, the symptoms, the inclinations to blame others: to blame others, proud words, intolerance, hypocritical, glory, and fulfillment.

Its "Elements of the Ideas and Elements" Idolology" in 1801 have included important views on the appearance, types and evolution, general laws. However, the concept of "Idolology" was often used in the sense of political threat, philosophical idealism, and the content of this term did not meet the primary interpretation of the author. For example, evil, corrupt ideas are not described in this work.
