At the end of the 2020-2021 academic year, the implementation of a number of decisions and decrees on the preschool education system on the ground, the coverage of children in preschool education at the expense of established governmental and non-governmental organizations amounted to 62%. In this regard, in the accelerated development of reforms, the Law of the Republic of Uzbekistan No. 595 of December 16, 2019, Chapter 11, Article 58 of the Law of the Republic of Uzbekistan No. 637 of September 23, 2020 The adoption of the Law of the Republic of Kazakhstan "On Education", Chapter 11, Article 75, allowed the further development of the system. Article 17 of the Law on Preschool Education deals with the types of preschool education, and Article 19 deals with the establishment and operation of non-governmental preschool education organizations. The President of the Republic of Uzbekistan Sh. Mirziyoev said in his address to the Oliy Majlis in 2020 that 600 billion sums will be allocated to increase the coverage of children in preschool education to 75% by 2023. This has increased the focus on preschool education.

Non-governmental preschool educational organizations are established on the basis of the following decisions:

On measures to establish non-governmental preschool educational institutions Presidential Decree No. PQ-3276 of September 15, 2017

On the establishment of non-governmental preschool educational institutions on the basis of public-private partnership Presidential Decree No. PQ-3651 of April 5, 2018

Resolution of the Cabinet of Ministers of the Republic of Uzbekistan No. 595 of July 30, 2018 on the procedure for issuing permits for the activities of family non-governmental preschool educational institutions.

Resolution of the Cabinet of Ministers of the Republic of Uzbekistan No. 944 of November 23, 2018 on measures to further expand the forms of public-private partnership in the field of preschool education.

Documents required for the establishment of family NMTTs (Resolution No. 595 of 30.07.2018)

- 1. Passing public services as an individual entrepreneur. Getting a seal on the organization being formed. Opening an account with a bank.
- 2. Documents related to the entrepreneur:
- 3. Application, copy of passport, certificate, inn, diploma (if not available, certificate).
- 4. Cadastral documents, certificate of state registration of the right to land.
- 5. DSENM and FIRE conclusions of the apartment where the organization is being established.
- 6. Documents (passport copy, certificate, INN) in the name of the person in whose name the organization is established.

- 7. A statement that the entrepreneur has no debts for utilities (electricity, gas, water, taxes).
- 8. The seal of the organization owned by the entrepreneur.
- 9. Lease agreement between the entrepreneur and the landlord, if the house in which the organization is established does not belong to the entrepreneur.
- 10. Photographs of the interior and exterior of the apartment and 2 empty rooms according to the condition of the apartment where the organization is organized
- 11. Documents of recruited pedagogical staff: passport copy, diploma copy.
- 12. Agreement between the entrepreneur and the state. Note: operates on the basis of a permit Documents required for the organization of NMT on the basis of non-governmental and public-private partnership (Resolution No. 944 of 23.11.2018)
- 1. Certificate of NMTT "XXXXXX"
- 2. Copy of the charter
- 3. Original copy of the decision of the district governor on land allocation;
- 4. A copy of the certificate of state registration of the right to land;
- 5. A copy of the certificate of state registration of the right to the building (if any);
- 6. Information on absence of arrears of taxes, fees, other obligatory payments and other financial sanctions not later than one month prior to the date of submission of the application;
- 7. A document confirming the ability of a private partner to finance at least 25% of the project cost or a guarantee from another organization;
- 8. Duly approved and agreed design estimates for the building of the planned non-governmental preschool educational institution;
- 9. Conclusions of the bodies of ecology and environmental protection of the region on the establishment of a preschool educational institution;
- 10. Conclusions of the state sanitary-epidemiological control bodies on the establishment of a preschool educational institution;
- 11. Preliminary feasibility study for the construction of a non-governmental preschool building.
- 12. Presentation (photo album) Note: operates on the basis of licensing.

Licensing on the basis of the Resolution No. 241 of March 27, 2018 "On the procedure for licensing activities in the field of non-governmental educational services":

- 1. Application
- 2. Certificate of NMTT "XXXXX"
- 3. Copy of the charter
- 4. Conclusion of the state sanitary-epidemiological control body
- 5. Fire Safety Administration Conclusion
- 6. Information about pedagogical staff
- 7. Curriculum for each group
- 8. Proof of payment of the application fee (2 times the minimum wage).
- 9. Expert opinion.
- 10. License Fee. (10 times the minimum wage).

Note: NMT activity is licensed for 5 years.

In conclusion, further expansion of the public and private sectors of preschool education is a requirement of today. An increase in the number of public and private preschools will help create a healthy competitive environment.
