By the decree of the Oliy Majlis of the Republic of Uzbekistan $N_{\rm P}$ 466 on August 29, 1997, the national program "raising the legal culture in society" was adopted . The purpose of the national program is to create a system of wide coverage of the formation of a legal culture so that all strata of the population can achieve legal literacy, have a high level of legal consciousness, as well as apply their legal knowledge in everyday life. The main objectives in achieving the stated objective are as follows:

- -Improvement of legal education and legal education system;
- -To ensure that all government agencies, officials and citizens are in a relationship with respect to law and law;
- Increase the legal literacy of the population;
- -It is defined as ensuring the social and legal activity of citizens.

The level of legal consciousness is that people are simply aware of the rights, not only know the laws, but first observe the laws and prepare them for their implementation, obey the law, respect for the right and Justice. Article 19 of the Constitution of the Republic of Uzbekistan: "the citizen and the state of the Republic of Uzbekistan are interrelated with their rights and duties in relation to each other. The rights and freedoms of citizens enshrined in the Constitution and laws are inviolable, who has no right to deprive or restrict them without a court decision."

Ensuring effective protection of human rights and legitimate interests, first of all, through judicial protection, is one of the most important tasks of the legal reform carried out in Uzbekistan. The firm belief that the legality and Justice of each person will triumph should be based on this, that a person who violates the law will not be punished, and everyone has the right to demand the restoration of the violated right, as well as the compensation of material and moral damage caused to him.

As the main measures for the implementation of legal education and training are defined as:

- -the state as the main organizer of legal education and training regularly improves the methods and means of education and training, the structure of institutions directly engaged in this activity, contributes to the formation of alternative systems of legal education and legal education;
- Ensuring broad cooperation of state structures and public associations in the field of increasing the legal culture of the population regular coordination of this activity and determination of future tasks to achieve one of the most important areas of activity of the Ministry of Justice and Public Associations of lawyers of the Republic of Uzbekistan;
- Implementation of legal education and training not only by educational institutions, but also with the participation of law-enforcement bodies and enterprises, as well as employees of the legal service of local government bodies;
- Development, approval of normative and educational-methodological criteria for legal education and legal education in pre-school educational institutions, secondary schools and introduction of new disciplines;

-To determine the educational institutions that deeply teach the basics of Legal Sciences and the number of legal personnel trained in them, taking into account the economic, social, demographic situation and other factors determining the society's need for relevant specialists; The article examines the most important issues of the formation of the rule of law and civil society in modern Uzbekistan. In the decree, in order to raise legal consciousness and culture in society, first of all, to pay special attention to the systematic and inalienable conduct of education, from the pre-school education system to the deep integration of legal consciousness and legal culture into all strata of the population, it has been determined to promote a wide range of ideas of maintaining a balance between personal interests and the interests of society. 1-annex to this decree "road map" on the effective implementation of the concept of "raising legal culture in society "and 2-annex" on the effective implementation of the concept of raising legal culture in society "were adopted. The ministries, which are authorized and responsible for the implementation of important tasks and functions defined in the concept and road map, specific works are defined to the relevant state institutions.

After all, the main condition for the construction of a legal democratic state and civil society is also a society consisting of highly spiritual and legal cultured persons.
