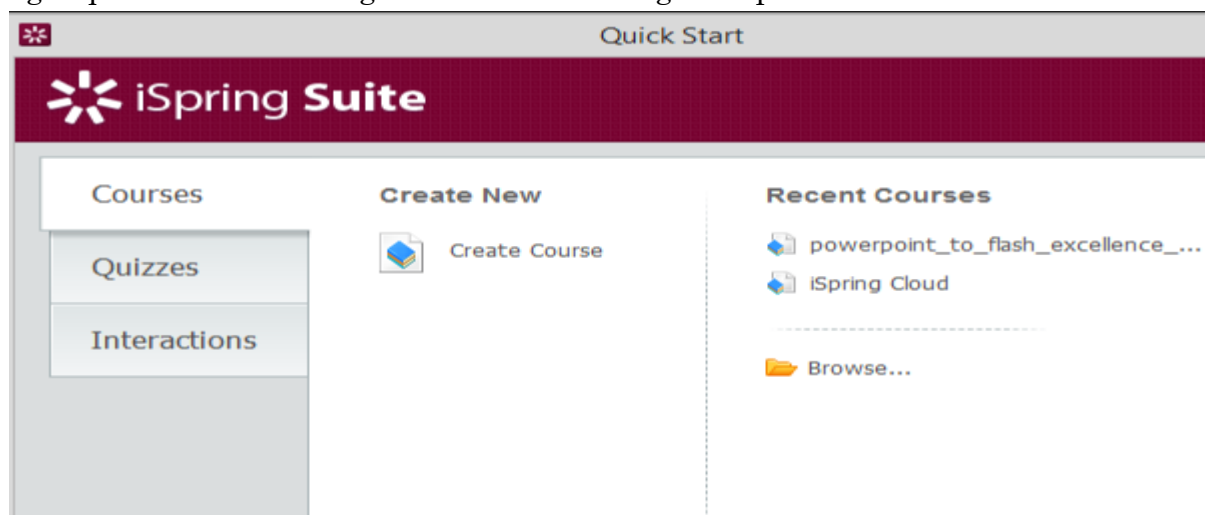

iSpring Suite 8's program is the simplest and most high – quality way to check students ' knowledge is through an assessment test. To create it, the menu "Novy test" is selected. the following types of test questions can be created using the iSpring program based on the iSpring program: Assessment of the correctness of confirmation.

1. Choosing the most correct answer option (one-choice test).
2. Selecting multiple answer options (multi-choice test).
3. Enter the question answer in the special field (enter the line).
4. Comparison of suitable elements (comparison).
5. Placing (sorting) the given options in the correct sequence.
6. Enter the correct answer option in the numerical form (enter the number).
7. Fill in the remaining vacancies in the text with suitable answers.
8. Select the correct answer option from the dropdown list.
9. Fill in the remaining vacancies using the options contained in the "jar slov".
10. Indicate the correct area in the image.

It is worth noting that in order to apply this style, it is definitely necessary to have a room equipped with a computer. In this style, questions are drawn up by the teacher on the topics covered in the subject of law. divided into sections, each section places questions structured from easy to complex within a specific time frame. Questions are easy-according to their complexity, questions are placed in 11 different styles. The advantage of this program is that it has prepared a reserve of questions of 50 of which ensures the operation of 15 optional test options for each reader.
