- the second phase, the teachings of the nineteenth and 12th centuries, the Islamic Awakening period (Koran, events, pandemics, the teachings of hypocrites: Forobi, Beroea, Ibn Sino);
- the third phase, the teachings that existed during the 14th and 17th centuries, during the reigns of Amir Tiberius and the Tyrians;
- fourth phase, theories of the time of the chambers (from the 16th to the 19th centuries);
- the fifth phase, theories of the period conquered by the Central Asian Chorssian (theories that existed in the late 1960's and the October 1917 Revolution);
- sixth phase, theories of the Union era (theories that existed from the October 1917 Revolution to August 1991);

The seventh phase, the Period of Independence, that is, from September 1991 to the present.
