ABSTRACT

We aim to be among the “Top” countries of the world by the level of development, and to achieve this goal, we will need a well-developed program. For the development of this program, experts and general public opinion were studied, and many of the proposals received were considered. The Uzbekistan-2030 strategy was developed, taking into account the problems, shortcomings and possible problems and shortcomings in the future. In this regard, the decree “on the strategy of action” was signed by our honored President Shavkat Miromonovich Mirziyoyev on September 11, 2023. It began with the words: "In a referendum held on April 30, 2023, the Constitution of the Republic of Uzbekistan in the new edition was adopted by Universal vote the fact that it was made served to strengthen the constitutional framework for the establishment of a new Uzbekistan. The presidential election held in accordance with the Constitution of the new edition once again testifies to the full support of our people for the political maturity of our society, the reforms that are being carried out towards the establishment of a new Uzbekistan. At the same time, under the updated constitutional and legal conditions, it is required to improve the main directions of the development of our country and bring the large-scale reforms carried out to a new level.”[1]

The Uzbekistan-2030 action strategy, which provides for the establishment of a system of education, medicine and social protection that fully meets the requirements and international standards of the population, creating favorable environmental conditions for the population, establishing a fair and modern state in the public service, ensuring the sovereignty and security of the country with guarantees, reflects 5 priorities and 100 goals. Priorities include: - to create suitable conditions for each person to realize their potential;

- ensuring the well-being of the population through sustainable economic growth;
- Water Resources Conservation and Environmental Protection;
- ensuring the rule of law, the organization of Public Administration in the public service;
- consistent continuation of policies based on the principle of a “safe and peaceful state”.

By the decree of the president of the Republic of Uzbekistan No. 158 of September 11, 2023, the composition of the Republican commission for the implementation of the strategy “Uzbekistan-2030” specified in Appendix 2 was approved. The role of chairman of the commission was given to the Prime Minister of the Republic of Uzbekistan Abdulla Aripov.[2] Article 2 of our Constitution states that the state expresses the will of the people, serves its interests. it has been noted that public authorities and officials are in charge of society and citizens.[3] it is clear

that one of the main directions in the strategy is aimed at ensuring the rule of law, the organization of state power in the service of the people.

This priority area consists of a total of 16 goals and is divided into two parts:

Reforms for the organization of Public Administration in the public service and the improvement of Public Administration; Ensuring the rule of law and reforms in the judicial system. The following are a number of tasks for the purpose of increasing the level of achievement of justice by strengthening the independence of the judiciary alone and ensuring openness in its activities: Achieving the participation of a defender or public defender in 100% of criminal cases committed against business entities; Full-fledged introduction of the principle of self-government of judges to the management of the judicial system, as well as the full formation of the system of bodies of the judicial community; Achieving a score of 0.64 on the rule of Law Index of the World Justice Project;

Achieving the accumulation of 61.5 points in the direction of the rule of Law of management quality indicators.[4] It is important to keep a long-sighted business in all areas, especially in the field of law. Keeping Up With The Times has become a requirement of the period. It will take a long time to make large and significant changes in the state and law. We hope that according to the end of this strategy we will see a new Uzbekistan that will develop a lot.
