### THE MAIN PART

Today, the effectiveness of service enterprises' activities directly depends on the basis of the strategy, and its formation is one of the main tasks of the leaders at the top management level. Improvement of the socio-economic mechanism of development of the activity of service enterprises is of particular importance in the constantly changing conditions of the external and internal environment, and makes it possible to maintain the leading position in the market.

The development of service enterprises has its own characteristics and aspects. Accordingly, it is of particular importance to theoretically clarify the specific characteristics of the development of this field and the development trends, which represent the influence of certain factors.

Historically, each type of service has been considered a separate field of activity with its own characteristics. The service sector itself is represented and listed as a combination of these many types of activities. All types of services can be divided into groups according to different classification symbols.

#### **Types of activities included in the category of household services provided to the population in the Republic of Uzbekistan:**

1. Shoe repair, dyeing and sewing - comprehensive operations on repair and restoration of the customer's (consumer's) shoes, including processing in accordance with sanitary and hygiene requirements, as well as preparation of new shoes according to the customer's requirements.
2. Repair and sewing of sewing, fur, leather and knitted goods, headwear and textile haberdashery - complex operations on sewing new items from various materials and repairing previously used items in accordance with customer requirements ;
3. Repair of radio-electronic devices and electric machines and equipment - comprehensive actions to restore the functionality of radio-electronic devices and electric machines and equipment.

Technical maintenance of radio-electronic devices and electric machines and equipment - complex actions to keep radio-electronic devices and electric machines and equipment in proper technical condition for their intended use.

5. Installation of radio-electronic devices and electric machines and equipment - complex measures and actions related to the preparation for operation of radio-electronic devices and electric machines and equipment.

assessment of the technical condition of the equipment in order to determine the suitability for future repair and use of the equipment and/or the reasons for its failure, stoppage, defects and damage.

7. Services for repair and preparation of metal products (metal constructions) - results of the performers' activities aimed at eliminating malfunctions of metal products and restoring their working capacity or manufacturing metal products.

and preparation of jewelry - complex operations that include preparation and repair of jewelry and processing of stones and their hardeners.

9. Preparation, restoration and repair of furniture - preparation, restoration and repair of soft, woven, body, sectional, kitchen, component, garden yard, children's and other furniture, as well as painting and complex actions on other matters.

10. Chemical cleaning and dyeing - used to remove stains from articles under the influence of various solvents, as well as impregnation with antistatic, anti-moisture substances and beautifying agents, ironing, stretching, combing and painting, as well as complex actions to restore the color of the item or change it.

11. Laundry service - complex operations for washing, drying and ironing of performers' clothes, bed linen, special clothes, as well as deodorization and disinfection.

12. Repair and construction of housing and other buildings - construction of individual houses, repair and reconstruction of housing, garden, farm buildings, bathroom, garage, cellar, stove, etc., as well as comprehensive operations in roofing, window installation, installation work, tiling, finishing work, carpentry, plastering, electrical installation, painting work, stone work, bricklaying, etc.

Technical maintenance of vehicles, machines and equipment - comprehensive actions to maintain the performance of vehicles, machines and equipment in a purposeful manner, waiting, storage and moving.

14. Photo studio, photo production laboratory (photo service) services - activities aimed at satisfying the individual needs of consumers (customers) for taking pictures, chemical processing of photo films, printing pictures on photo paper and objects.

15. Film services - activities aimed at satisfying the needs of the consumer related to filming a movie, sending the finished product to the customer in electronic form or on film.

16. The service of bath and wellness complexes is an activity aimed at satisfying the needs of the consumer related to hygiene and wellness.

17. Hairdressing service is an activity aimed at satisfying the aesthetic and hygienic needs of the consumer.

18. Face and body skin care service (cosmetics service) - physical and chemical effects on the face and body, eyebrows and eyelashes of the consumer in order to rejuvenate it, as well as facial decoration using decorative cosmetics in order to satisfy the aesthetic needs of the consumer.

chemical treatment of the consumer's fingernails and skin for their health and protection to meet the consumer's aesthetic needs.

preparation and repair of wigs, artificial mustaches, beards, sideburns, hair extensions, hair accessories and hair accessories based on the customer's individual order.

21. SPA service - health care, cosmetic and/or recreational services provided in high comfort and based on SPA technology.

22. Cosmetic tattoo - services of a cosmetic nature to satisfy the client's aesthetic needs by injecting pigments into the human skin.

23. Leasing - complex operations on the provision of movable and immovable property, whose circulation in the territory of the Republic of Uzbekistan is not prohibited by law, to individuals for temporary ownership and use, based on the principles of property lease.

complex operations on burial, cremation, pre-burial preparation, organization of funeral ceremony, preparation of objects related to burial (tombstone, statues, etc. ).

complex organizational measures and technological processes for cleaning buildings, structures, areas, restoration of surfaces, disinfection and disinsection on the orders of individuals .

26. Household management services - activities related to satisfaction of the consumer's need for household management services by the executive.

### CONCLUSION

To date, there is no coherent definition of services. In determining a certain description according to its socio-economic essence, the description of services in terms of their social importance and economic result, as opposed to material goods, is of particular importance. In this case, the activity related to meeting people's needs is considered as an important feature of services, and it appears as the final result of a concrete form or type of activity .
