Copyright relations are governed by the laws of each country and international conventions (from the National Encyclopedia of Uzbekistan).

Copyright is a branch of civil law aimed at protecting the intellectual property of individuals. On July 20, 2006, the Law on Copyright and Related Rights No. ZRU-42 was adopted. This law became a guarantee of the development of science and enlightenment in the Republic of Uzbekistan. Because this law guarantees the protection of a number of forms of intellectual property, such as our literature - ballads, poems, plays (drama, tragedy, comedy), stories, short stories and novels, scientific literature, scientific inventions, technical inventions. Of course, all of the above properties are directly related to materiality. If a person does not receive a decent reward for the intellectual blessings he has created on the basis of his labor and intellectual ability, then it can be easily appropriated by other people, then who will invent it, who will finish the book. For this reason, there was a need to develop this law. Let me quote a few quotations from this law as proof of my point.

Chapter 5 Copyright and related rights protection.

Article 61 Liability for Violation of Copyright and Related Rights Legislation.

Violators of copyright and related rights laws will be held accountable.

Article 65 The author, the owner of related rights or another owner of exclusive rights has the right to demand from the offender:

- -Recognition of rights;
- Restore the pre-offense situation and stop actions that violate or threaten to violate the law;
- Indemnification of damages in the amount of income that the right holder could receive in the normal course of civil proceedings, but could not receive, if the rights of the right holder are not violated. If the infringer has received income as a result of copyright or related rights infringement, the right holders shall recover, among other losses, the lost profit in an amount not less than such income;

- To pay compensation, regardless of the fact of infliction of damages, taking into account the nature of the offense and the degree of guilt of the offender, taking into account the customs of the offender;
- Take other measures provided by law to protect their rights under this Law.
- The author and the performer have the right to demand moral damages from the offender in case of violation of their rights.
- An organization that manages property rights on a collective basis has the right to apply to the court on its own behalf in the manner prescribed by law to protect the infringed copyright and related rights of persons whose property rights are managed by such an organization.

Damage caused to third parties as a result of taking necessary measures to prevent or stop the infringement of copyright or related rights, as well as damages incurred by the person who took such measures, shall be recovered from the offender.

Several articles of the above-mentioned law show how well copyright is protected in the Republic of Uzbekistan. As you can see, as intellectual property rights are protected and encouraged by authors, and creators and inventors are valued for their work, their love for their work doubles and more. they strive to create. By working on themselves, they benefit our people, our country, our state, and contribute to its development.
